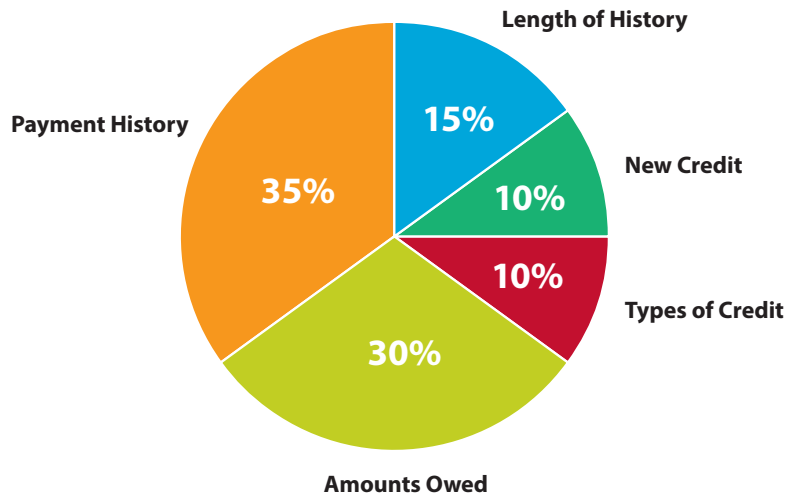


# What Determines My Credit Score?
